# Record of Proceedings Village of Bremen Council Meeting January 11, 2016

The Council of the Village of Bremen was called to order in regular session by Mayor Tad Moyer at 7:00 P.M. ## Sheriff's Report: (Deputy Busby)

Deputy Busby passed out his monthly report to members of Council.

Mayor Moyer read his report to council. The Mayor gave a "changing of the guard" speech to the council and those in attendance of the meeting. His speech outlined Bremen's past and where he would like to see Bremen go during his tenure in office.

# Clerk/Treasurer's Report: (Kelley Tripp)

The Clerk submitted a report to Council. Highlights of the report are as follows:

- Our current checking balance as of December 31, 2015 is \$516,080.54.
  - November 30, 2015 was \$561,609.45
- Our fund balance as of December 13, 2015: (read report to council).
- We have spent 1.61 percent of our temporary appropriation budget for 2016.
- We have received 0.00 percent of our annual revenue budget for 2016.

#### Administrator's Report:

The Village Administrator submitted his report to Council which included the following items he has worked on since the last council meeting:

- Attended meetings of the Villages standing committees;
- Produced and issued the newsletter, The Village Voice, for the public;
- Represented the Village at the Fairfield County Regional Planning Commission;
- Conducted a public involvement meeting regarding the Safe Routes to School project on 12/15/15;
- Followed Village Council's decision to stop providing for recycling as of the year end.
   Waste Management has removed recycling dumpster the last week of December;
- Continue to gather information for the 2016 Permanent Budget;

- There have been two water main breaks this season on Highland Blvd and School Street. In both cases the lines were cast iron laid in the 1960's;
- Working on developing an infrastructure inventory system, so the attributes and condition of the Village's streets, curbs/gutters, water lines, sewers, etc. can be better monitored.
