Record of Proceedings Village of Bremen Council Meeting August 12, 2019

The Council of the Village of Bremen was called to order in regular session by Mayor Mike Henwood at 7:00 P.M. Roll call was taken. Members present were Toni Harper, Sue Henwood, Scott Snider, Todd Wesaw, and Debbie Wolfe. Sherman Prince was an excused absence. Fiscal Officer Crystal Pritchard, Administrator, Corey Spackey and Sheriff's Deputy Kristy Peck attended.

Guests and Residents:

Dan Rutherford: Has been working with Worthington to make sure the handicapped swing is up to code. Scott Snider offered to help install the swing when Dan is ready to install it. Dan said that the install would be sometime after the fundraising event on August 24th. Has had several kids' books donated. Would like to put a free library for kids to come by and pick up a book. Dan would like to put it in front of the municipal building.

Mrs. Boch and Ms. Schmeltzer: Mrs. Boch is relatively new to the community. She walks daily in the park and has really enjoyed it. Professionally, Mrs. Boch has a nonprofit business where she does a lot of health and wellness promotion in the community. One of the things her nonprofit does is grant writing. She spoke to Debbie about getting permission to write a grant to pave the walk way. She noticed that there are a lot of individuals that walk on the paved path and there are several areas that could be upgraded. She is willing to volunteer her time to look at the feasibility of writing a grant for the park if council will allow her to do so. Council all agreed that they would fully support her efforts.

Anthony Taylor: Would like to make a public records request for the following items:

Mike McCoy: Neighbor across the street from him at 417 N. Broad St. continues to blow grass into street on New Street side and North Broad street side of his house. He spoke to the neighbor and told him that it was illegal and dangerous for motorcycle drivers. The neighbor told him he's done it for 20 years and would continue to do it. Mr. McCoy has a video of him doing this if any members of council would like to see it after the meeting.

Approval of Minutes

Sheriff's Report: (Deputy Peck)

Deputy distributed her monthly report to Council; there were 43 calls for service in July. Ten reports were taken and several misdemeanor and juvenile charges filed with the courts. There was a one vehicle accident where a car hit a house on the corner of Marietta Street and Mulberry Street. OSP took control of the scene due to the subject allegedly being on

some sort of narcotic. There was an incident involving several juveniles playing a door dash game (ringing doorbells and leaving the area). Juvenile charges were forwarded to the prosecutor for review. There have been several burglaries in the village and surrounding areas. These are often times crimes of opportunity. Residents need to remember to lock their doors and close their garage doors. There were no major incidents to report. Debbie Wolfe asked the deputy for an update on the August 8th vandalism incident in the women's bathroom at Howell Park. Deputy Peck is aware of the incident and looking into the matter.

Mayor's Report:

School starts again on Thursday, 8/15. Mayor Henwood asked the deputy to make sure she's in the area Thursday and Friday to ensure that people are driving correctly and being safe in the area. Mayor Henwood also asked that Deputy Peck stop by the garage on the corner of Strayer Ave. and Angle St. to see if he could move his cars back. There isn't a clear line of sight when the cars are sitting that close to the road. Mayor Henwood and Crystal Pritchard worked with RCAP regarding the WPCLF loan for the WWTP upgrades. We have signed the loan documents for the \$175,900 loan.

Frank Fondale has passed the state test for his Class I water license.

A new pool vac has been ordered for the pool for next season. It should be delivered sometime next week

Corey would like to acknowledge and say a big thank you to our pool manager, Trent Johns and the great group of lifeguards that we had for the 2019 pool season. They did an exceptional job this season.

A tree dedicated to Lloyd Householder was damaged by a weed eater and as a result has died. It will be replaced as soon as possible. Sue Henwood stated that she would like to buy the tree for Lloyd.
