
T. Tripp said old NAPA LLC. changes name every time they send letter to be condemned.

Mayor A. Taylor discussed wells. Well one last well replacement was 1996 and well two last well replacement was 2010. Both well pumps replaced 2023.

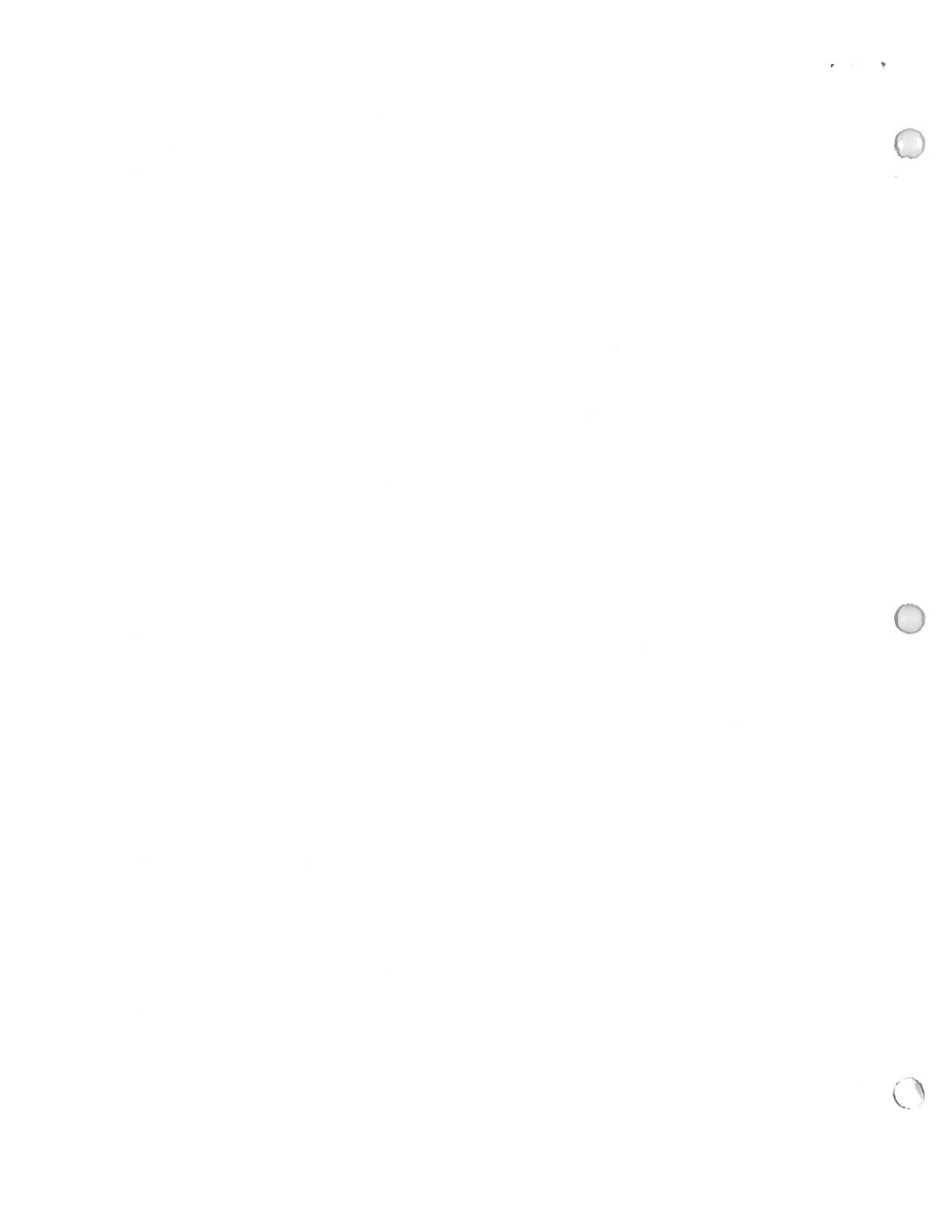
