AN ORDINANCE SETTING AND APPROVING THE 2023 VILLAGE OF BREMEN RIGHT-OF-WAY PROGRAM'S CERTIFICATE OF REGISTRATION FEE AND CONSTRUCTION PERMIT FEE AND DECLARING AN EMERGENCY

WHEREAS, Council for the Village of Bremen previously adopted legislation regulating the use of the public rights-of-ways; and

WHEREAS, Sections 97.05 and 97.13(D) of those regulations require Council to annually calculate and establish the Certificate of Registration Fee and Construction Permit fee; and

WHEREAS, although the year is more than half over, Council for the Village of Bremen now wants to lower and set the rates for 2023. The current rates are as follows: Registration Fee - \$342.68 / Construction Permit Fee - \$281.84.

NOW, **THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREMEN, FAIRFIELD COUNTY, STATE OF OHIO:**

SECTION 1: Council for the Village of Bremen hereby sets and approves the following 2023 right-of-way fee schedule:

- ❖ the Certificate of Registration Fee shall be calculated at \$308.24 per encumbered mile
- ❖ the Construction Permit Fee shall be \$259.45 per permit

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION 3: All prior legislation, or any parts thereof, which is/are inconsistent with this Ordinance is/are hereby repealed as to the inconsistent parts thereof.

SECTION 4: Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that the Village needs to set these 2023 fees as soon as possible. Wherefore, provided this Ordinance receives the required


