### **Please read the following policies regarding your pool party before signing:**

1. All existing pool policies, pool rules and park regulations must be followed during the party. I have read and understand all the rules of the Village of Bremen Swimming Pool.
2. It is my responsibility to ensure that all persons at this pool party abide by these rules and give the Pool Staff due respect. Failure to do so may cause the Pool Personnel, for disciplinary reasons, to end the party with no refunds.
3. To receive a full refund, parties must be cancelled at least 7 days prior to the date of the party. All refunds are subject to a \$15.00 processing fee.
4. Parties that cancel on the day of party due to expected severe weather at least one hour prior to start time will receive a full refund. If bad weather is expected, the party will be contacted prior to the party. If the party wishes to have a party and bad weather occurs no refund will be made.
5. Parties must be paid for at the time of reservation.
6. No cooking on premises. No alcohol. We have the right to check bags and coolers.
7. No live bands unless cleared with the Village Administrator.
