A RESOLUTION TO TENTATIVELY AWARD CONSTRUCTION CONTRACT FOR THE WATER METER PROJECT

WHEREAS, the Village of Bremen wishes to construct Water Meter Project Improvements, and

WHEREAS, on June 27th, 2024, bids were received for the Water Meter Improvements;

WHEREAS, the Village Council wishes to tentatively award the contract to the recommended best bidder, contingent upon receipt of an ODOD Grant approval; and

WHEREAS, said recommended best bid for the project is Jackson Brothers Construction in the amount of \$773,000.00 (original bid \$773,000.00).

WHEREAS, the Engineer, Verdantas, has recommend awarding the bid as detailed above, and

WHEREAS, the Mayor shall be authorized to execute the Notice of Award and the Agreement for the contract as all funds are secured, now

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BREMEN, FAIRFIELD COUNTY, STATE OF OHIO:
