A RESOLUTION TO ESTABLISH THE PRICES AND FEES FOR THE VILLAGE OF BREMEN SWIMMING POOL FOR THE SWIMMING SEASON

WHEREAS, Resolution 2025-3-R supersedes Resolution 2024-4-R passed March 11, 2024.

WHEREAS, It is necessary to establish the pricing for entry fees and pool rental fees; and

WHEREAS, the Committee on Financial Process has reviewed and agreed to the following proposal.

NOW THEREFORE, be it resolved by the Council of the Village of Bremen, state of Ohio:

SECTION ONE: Daily Entry Fees

Age	<3	No Charge
Age	3 & up	\$4.00P
New evening Rate		\$2.00 4pm-7pm

SEASONAL PASS RATES

Household (up to 6 people living in the house)	\$225.00
Household (up to 6 people living in the house) – July only	\$130.00
Other additional people in household	+\$30.00
Babysitter on Household pass	+\$30.00
(Babysitter cannot use household pass for personal use)	
Daycare Pass	\$350.00 (per 10 people)
Employees and immediate family	Free

Half season pass starting July 1, 2024: Family \$125.00 and individual \$60.00.

Individual Passes

Age 11 & Up June/July	\$80.00
Age 11 & Up July only	\$50.00

All children 10 years old or younger must be under the supervision of another person, 16 years and older. There are no early Pool Pass sales.

SECTION TWO: POOL PARTY RENTAL

All Pool parties under 50 people	\$225.00
All Pool parties over 50 people	\$275.00

Payment must be made upon scheduling at the Village Office.

All pool parties will be limited to two hours.

Monday, Tuesday, Thursday, Friday, Saturday	7:00 pm to 9:00pm
Wednesday and Sunday	6:00 pm to 8:00pm

50 people or less shall require two lifeguards
More than 50 people shall require three lifeguards
All parties attending are counted whether they swim or not.
No parties greater than 150 people.

Those wishing to cancel their party must do so within 7 days of their scheduled date in order to qualify for a refund. All refunds are subject to a \$15.00 processing fee. Cancellations by the Village of Bremen due to inclement weather or other unforeseen circumstances shall be fully refunded.

SECTION THREE: SWIMMING LESSONS

Swimming Lessons will be provided contingent upon the availability of instructors and a sufficient number of registrants for any given class group. Scheduling of swim lessons will be at the discretion of the pool manager.

SECTION FOUR: LIFEGUARD TRAINING AND REIMBURSEMENT


