A RESOLUTION AUTHORIZING FEES FOR THE USE OF PARK FACILITIES

WHEREAS, The Village of Bremen invites residents and patrons of our Village Parks to use and enjoy the many amenities available to the public;

THEREFORE, Be it ordained by the Council of Village of Bremen, State of Ohio which has set for the following park arrangement with set fees as follows:

SECTION 1: The Village charges for the use of the shelter house and concession stand in Howell Park:

Shelter House Rental	4 hours	\$30.00
Shelter House Rental	8 hours	\$50.00
Concession & Shelter House Rental	4 hours	\$50.00
Concession & Shelter House Rental	8 hours	\$75.00
Concession & Shelter House Rental NON-PROFIT	4 to 8 hours	\$20.00

Payment for Shelter House and Concession use must be given at the time of scheduling the event.

A concession key sign out form must be filled out to receive the key for the concession stand. Also, if rental date is on a weekend or Holiday the key must be picked up prior to the date of rental.

SECTION 2: The Village of Bremen has set forth the following rules to coincide with the fee schedule:

- A. Alcohol use is prohibited in any of the village parks. Patrons will be asked to leave and will not be eligible to rent the facilities in the future.
- B. The restrooms are open from 8:00AM to 8:00PM for the use of everyone in the village parks. Please be respectful and clean up after your guests when using the restrooms.
- C. No nails or staples are to be used to hang banners/decorations/signs on the posts or walls of the building. Patrons may use tape or tacks; however, we ask that they be removed from those areas upon completion of the event.
- D. DO NOT USE extension cords while using park facilities.
- E. If a patron reserves the concession stand, the patron is responsible for cleaning the countertops, stove, refrigerator and floor.
- F. The Village of Bremen is not responsible or liable for unsafe use of any of the facilities at Howell Park.

The Village of Bremen has designated a person to verify all the rules and regulations have been followed.

SECTION 3: The Village of Bremen also provides the use of the following items in their

Parks and recreation areas:

- A. If a patron reserves the concession stand, games and athletic equipment stored inside the concession stand are available for use by the rental part.
- B. Pet friendly litter bags are at various locations throughout the park. Please use them if animals are brought to the park.

Please take advantage of all the facilities at the park! There are basketball and tennis courts, softball/baseball fields, cornhole boards and horseshoe pits. Most of the trees are marked and labeled around the walking paths and Monarch Waystation in the Butterfly Garden is an added attraction. The playgrounds are available for small children with adult supervision.

SECTION 4: This resolution shall take effect and be in force after its passage as allowed by law.
